

SANDOVAL COUNTY BOARD OF COMMISSIONERS
REGULAR MEETING MINUTES
COMMISSION CHAMBERS
JANUARY 8, 2015 – 6 P.M.

1. CALL TO ORDER

Chairman Madalena called meeting to order at 6:04 p.m. Present were Chairman Madalena, Commissioner Chapman, Commissioner Walters, and Commissioner Dominguez. Commissioner Scherzinger joined the meeting via telephone for Item 6A & 6B.

2. PLEDGE OF ALLEGIANCE

Pledge of allegiance was led by Deputy Sheriff Jacob Trujillo.

3. INTRODUCTIONS & ANNOUNCEMENTS

Chairman Madalena asked for a moment of silence for the passing of Commissioner Scherzinger's husband Victor Scherzinger.

Chairman Madalena announced that there was a change of tribal leaders in all pueblos. Please see attachment for the full list of new tribal leaders.

4. PROCLAMATION & PRESENTATIONS

- Recognize Rio Rancho High School Rams – Class 6-A State Champions and Designate January 9, 2015 as “Rio Rancho High School Rams Football Day” (Commissioner Walters)
Commissioner Walters read the proclamation designating January 9, 2015 as “Rio Rancho High School Rams Football Day”. The Commission congratulated the Rio Rancho High School Football team on winning their first Class 6-A State Championship.
- 2014 Deputy of the Year (Doug Wood, Sheriff; Karl Wiese, Undersheriff)
Undersheriff Wiese recognized the Sandoval County Captain, Lieutenant and several Sergeants that attended the meeting.
Undersheriff Wiese recognized Deputy Jacob Trujillo and presented him with a Certificate of Commendation in recognition of his selection as class valedictorian of the NM Law Enforcement Academy Basic Police Officer Class #189.

Danielle Duran, PNM, External affairs briefed the Commission on the PNM 2014 Rate Case.

Commissioner Walters motion to approve, second by Commissioner Chapman. Motion passed. Vote was unanimous.

6. SANDOVAL COUNTY COMMISSION

(Chairman Madalena)

A. Request for a Motion to Adopt Resolution No. 1-8-15.6A Establishing the Sandoval County Board of Commissioners 2015 Open Meetings Act – Compliance and Public Meeting Notification Procedures

Commissioner Scherzinger joined the meeting via telephone.

Attorney Trujillo gave an overview of the Sandoval County Board of Commissioners 2015 Open Meetings Act and briefed the Commission on changes that were made.

Commissioner Walters motion to strike 3 words in section E.1 (a): *at the conclusion*.

Second by Commissioner Chapman. Motion passed. Vote was unanimous.

Commissioner Walters motion for Chairman Madalena to call Item 6A as amended back on the agenda when Attorney Trujillo is ready with modification. Second by Commissioner Scherzinger. Motion passed. Vote was unanimous.

Commissioner Chapman motion to amend section III.A.1 second sentence to read:

The Chair, the County Manager, or a majority of the members in a previous open meeting *at the initiation of at least one member* may place an item on the agenda. Second by Commissioner Walters. Motion passed. Vote was unanimous.

Commissioner Walters motion to strike final sentence in section F.1. Second by Commissioner Chapman. Motion passed. Vote was unanimous.

Commissioner Walters motion to approve as amended, second by Vice Chairman Dominguez. Motion passed. Vote was unanimous.

B. Election of Chairman and Vice Chairman for 2015

Commissioner Chapman motion to nominate Commissioner Walters for Chairman, second by Commissioner Walters. Commissioner Dominguez motion to nominate Chairman Madalena for Chairman. Second by Commissioner Scherzinger.

Commissioner Chapman motion to close nominations, second by Commissioner Walters.

Vote taken for Commissioner Walters as Chairman. Commissioner Chapman and Commissioner Walters vote Yes. Commissioner Dominguez, Commissioner Scherzinger and Chairman Madalena vote No.

Vote taken for Chairman Madalena as Chairman. Commissioner Dominguez, Commissioner Scherzinger, Commissioner Walters and Chairman Madalena vote Yes. Commissioner Chapman abstained. Chairman Madalena will remain Chairman for 2015.

Commissioner Scherzinger motion to nominate Commissioner Dominguez for Vice Chairman, second by Commissioner Dominguez. Commissioner Walters motion to nominate Commissioner Chapman for Vice Chairman, second by Commissioner Chapman. Commissioner Walters motion to close nominations, second by Commissioner Chapman.

Vote taken for Commissioner Dominguez as Vice Chairman. Commissioner Scherzinger, Commissioner Dominguez, and Chairman Madalena vote Yes. Commissioner Walters and Commissioner Chapman vote no. Commissioner Dominguez will be Vice Chairman for 2015.
