This will insure that we have an Investment Policy that is worked on by the STIC and brought before you by your elected County Treasurer and approved with your advice and consent. This will follow true intent of what I believe the law intended.

3. SANDOVAL COUNTY INVESTMENT POLICY

Discussion and Request for a Motion to Adopt Resolution No. 9-17-15.3 Approving the Sandoval County Investment Policy and Ratifying Certain Investment Made from October 2009 through September 17, 2015.

County Attorney Patrick Trujillo advised the Commission on the investment policy. Commissioners made their comments on the investment policy. Manager Rios also spoke about the investment policy. Commissioner Walters motion to amend dates on pg. 1 and pg. 2 of resolution, second by Commissioner Scherzinger. Motion passed. Vote was unanimous.

Commissioner Walters requested that the County Treasurer be involved in all updates and revisions to the investment policy and that more time be allowed for Board of Finance meetings.
