

**SANDOVAL COUNTY BOARD OF COMMISSIONERS  
REGULAR MEETING MINUTES  
COMMISSION CHAMBERS  
OCTOBER 3, 2013 – 6 P.M.**

1. CALL TO ORDER

The meeting was called to order at 6:03p.m.

Present were Chair Madalena, Vice Chair Scherzinger, Commissioner Lucero, Commissioner Chapman and Commissioner Walters.

3. INTRODUCTIONS & ANNOUNCEMENTS

Commissioner Chapman acknowledged State of NM Bureau of Elections Director Bobbie Shearer. 11. COMMENTS FROM THE COMMISSIONERS




Motion passed. Vote was unanimous.




