I attended the October hearing of your Commission. My thoughts at the time were "I can support any alternative energy project". I heard many residents from Puertocito Rd state their opposition to the solar array. That caused me some concern.

So I went home and spent time on my computer. I used the terms "solar farm fires" and "lithium battery fires" for the search engine.

I was astounded by the great number of results that I got. I learned that in the US there is no repository for the incidence of solar farm fires. Germany tracks those that occur in Europe. I learned that the State of New York has had 3 solar farm fires in the past 12 months. I learned of a fire in Surprise, Arizona that critically injured the local Fire Chief and another 8 first responders.

The more I learned, the more I reevaluated my position on Solar farm fires.

I purchased a USGS map of the affected area. I could not learn the exact location of the projected solar farm from the data that PCR provided at your hearing. I am suppling you with a copy of my map.

What I learned next heightened my concern. I measured the distance from the BESS area of the project to the foothills of the Sandia Mountain. It is only 1.7 miles!

I see thousands of dead trees in the Sandias from my kitchen window. These are kindling for any wildfire. That terrifies me as I would lose my home in a wildfire!

Another East Mountain resident who worked 13 years installing the hardware for solar farms told me that fires "happen all the time, usually from poor quality workmanship".

I hope we never experience a wildfire in the mountain. Or you will become known as the Commission that voted to risk fires in the Sandia. And the headlines in the Albuquerque Journal will excoriate the Commission. Please remember that we need only one fire for a devastating outcome.

I am writing in support of the proposed Diamond Tail Solar and Battery Project near Golden, NM. The devastating effects of climate change are already readily apparent in the East Mountains where I live. Our beloved piñons are dying, our wells are drying, and both wildfire risk and insurance rates are soaring.

This project is an important step towards displacing the climate pollution and untenable water use of the Four Corners coal plant- to the benefit all New Mexicans. It will provide low-cost electricity to PNM ratepayers like me. It will generate increased economic activity and tax revenue for East Mountain communities and support the development of a clean energy workforce. It will also fund Bernalillo schools and offer a living conservation and renewable energy laboratory for East Mountain students.

I had the opportunity to visit the site. Roch, the Diamond tail ranch manger told me that the cousins who recently inherited the land call it a treasure. The income from the solar and storage farm will allow them to continue the conservation work the Roch is doing – restoring this important watershed from overgrazing and eliminating invasive species such as salt cedar. Without the income, the new owners were advised to sell the ranch for housing developments, which no one in the East Mountain community supports (i.e., see Campbell Ranch). Solar farms themselves can enhance biodiversity and pollinator habitat, similar to reefs in oceans.

Concerns about fire are valid. It would be appreciated if Sandoval County contributed to upgraded maintenance of the roads for emergency fire response to the entire area. But my worries about fire risk from the 2-acre battery farm have largely been assuaged by the Sandoval County Fire Chief's approval of the design and emergency response plan, the use of LiFePO4 batteries instead of Li-ion, and by Tesla's adherence to the most up-to-date fire standards. The ranch manager is amenable to the use of his surveillance system for fire monitoring too, and he and his assistant plus the operations staff will be there practically every day. If we do not transition to carbon-free energy the fire risk will only grow as temperatures rise, vegetation requires more water to survive, and water becomes more scarce (https://geoinfo.nmt.edu/publications/monographs/bulletins/164/).

The San Pedro Creek Estates (SPCE) Homeowners Association (HOA) has recently learned about the Diamond Tail Solar and Storage Project proposed by PCR Investments SP4 LLC. We are aggrieved that the SPCE HOA has not received written notification from Sandoval County about this industrial 1,800-acre project, located within 5 miles of our community, since our HOA members will be affected by this development should it move forward. We also know that many of our neighbors who are adjacent landowners are formally opposing this project.

We recognize that growth and change in the East Mountains may occur. However, we expect our governing bodies to act responsibly and in the best interest of all. Many SPCE owners and Board members have attended PCR's public meetings and have been trying to research the aspects of PCR's plans and potential impacts, but many questions remain unanswered. Accepting PCR's rushed application indicates a lack of consideration for the harm it will bring to the quality of life of Sandoval County citizens.

We have many concerns, some of which include:

- Access to and use of an already dwindling water supply during construction (the underestimated 20 water trucks per day) and operation, and for on-site fire suppression. The source of water to support this site remains unclear.
- **High risk for fires** in close proximity to the Sandia Mountains and firefighters' response time 30+ minutes (at best) on single lane dirt roads which could easily become impassible.
- **Environmental impacts** from toxic chemicals and contamination from solar panels and batteries that could pollute our aquifers and wells. Environmental impact studies and required updates to current conditions are still pending.
- Disruption of wildlife in this area which is directly east of the Sandia Mountain Wilderness.
- Visual impacts, reflection and glare as well as dark night sky contamination from on-site lighting –
 especially along the Turquoise Trail National Scenic Byway and to thousands of Sandoval
 County residents whose property values might be impacted. Only one preliminary visual simulation,
 from only a single point of view has been shared with the public.
- PCR's lack of experience with large-scale solar arrays and BESS lithium battery energy storage –
 as well as the lack of a contract or connectivity design with PNM.

As you know, based on the Sandoval County Comprehensive Zoning Ordinance, the Board of County Commissioners may not grant a Zone Map Amendment for establishment of a Special Use District unless satisfactory provisions have been made to assure that the Special Use District will not become detrimental to the public health, safety, or general welfare of the County – all of which appear to be serious issues for a solar farm project of this magnitude.

In short, while we are support renewable energy efforts, we oppose a zoning change that would allow this project to proceed at the proposed location given the lack of adequate information. SPCE and East Mountain residents are clearly faced with a real risk of future injury if you approve PCR's application. We respectfully request that you take the time required to fully evaluate everything necessary for this zoning change request to be dispositioned in a sensible and responsible way.

Thank you for taking our concerns into consideration before making any decision, and thank you for your service as members of the Planning and Zoning Commission.

I really need to voice my opinion on this extremely contentious project, in support of the zoning change.

Basically, I'm pro-farm and don't understand the fervent and often irrational opposition to it, which in my opinion is being stirred up by exaggerations or outright lies.

Note that I'm one of the founding members of the Turquoise Trail Preservation Trust, the first group that I'm aware of that wanted to preserve the Turquoise Trail. That group has morphed into others, and the latest is EMPAC, which I'm sure you're familiar with.

1) Necessity

We as a society very much need to switch away from fossil fuels, and solar projects such as this are vital. The siting for this one is ideal, along existing power lines and near an existing substation, on a very large private ranch. Let's not be totally NIMBY about this.

2) Outright lies

I see over and over again "5.5 square miles" yet this makes no sense. 1800 acres divided by 640 acres/sq. mile comes out to about half that popular, frightening number. I contacted EMPAC, politely asking how they came up with that simple number... no reply. This project needs to be looked at on the basis of facts. 5.5 square miles is a lie. (I've also heard "5 1/2 square miles paved over!"... not so.)

3) Fire

Fire is a big concern, and I've seen social media comments about "burning down the Sandias" as well as evacuating Albuquerque. My degree is in engineering, and I've looked at PCR's batteries and the current failure rate and the systems they will have in place for such problems as a fire. I'm not concerned. There is some risk in any endeavor, and I think this one is definitely acceptable.

Before my engineering days, I spent 16 seasons working on forest and range fires with the Forest Service. Having been through the Diamondtail property numerous times, and knowing how PCR will site the batteries (with large gravel buffers), I'm not concerned in the slightest. Yes, a battery fire is not a good thing, but the chances are low, and precautions are being taken in the unlikely event that one would happen.

The anti-solar folks are hyping this as a disaster guaranteed to happen. Forget that, and please look at the facts.

4) Visual issues

The proposed farm is 2 miles off of Hwy 14. I drive from San Pedro to Albuquerque, and there are very few places from which it would be seen. It's probably different north of Golden, but I haven't done a check on that. Yes, it can be seen from some places. That's ok by me. Compare that with the places much of the opposition has been stirred up from.... Paako, San Pedro Creek, The Overlook. Those 'developments' are many times larger than the solar farm would be, and they're right along the scenic byway, not 2 miles distant. When I moved to the East Mountains, none of that was there. The Scenic Byway started being scenic right after where the roundabout is being put in. No more. Folks from any of those 3 subdivisions complaining about visual impacts are hypocrites.

5) EMPAC.

You might have seen that they circulated a list of questions for the community meetings (the first of which was a total farce due to the 'audience') designed to completely disrupt any intelligent conversation about the issue. Examples:

" How long will it take to construct additional High Voltage transmission power lines?"

Answer: The site was chosen because of the existing lines.

"What is the basal density of Juniper trees in the neighboring lands adjacent to the solar farm? How does this basal density compare to the nearby Sandia National Forest?"

Answer: This is ridiculous, and I say that as one who is quite experienced in wildland fire matters. It's a question thrown out there just to gum the things up.

Etc.....

6) Real issues:

Traffic and dust on Puertocito Road A road through the Chavez Ranch Where is the water going to come from?

Yes, there are issues to be worked out, and I think that PCR is willing to work with our community. This is just Step One. They should be allowed to go forward with their planning. And we'll see the details (and can object or help guide the process) as we go forward.

7) Bottom line:

As one who has been involved in preserving the East Mountain community for the last 30 years, currently as a board member of the SPNA (San Pedro Neighborhood Assn.) and one of the founding members of the Turquoise Trail Preservation Trust, I'm appalled at the resistance to the project, and am doubly appalled at the lies promulgated on social media and by EMPAC, and being believed by the gullible. Please look beyond all that.

Dear Director Beaman,

I am a resident of Puertecito Road in eastern Sandoval County and am submitting these comments to the record for the Planning and Zoning Commission meeting scheduled for December 10, 2024, which I am unable to attend in person. I attended the Planning and Zoning Commission meeting on October 8, 20024 and presented my comments on Agenda Item ZNCH-24-005, PCR's application for a zoning change from Rural Residential to Special Use. The commission postponed their decision that evening, instructing PCR to conduct more public outreach and information sessions. As Puertecito Road is a significant access route for their planned solar installation, and indeed my residence was clearly mapped in their application map of adjacent residencies, I was quite perplexed that I had not been contacted directly by PCR, as a stakeholder in the impact of this project. After the October P&Z meeting, and the commission's instructions to PCR, I was forwarded (by my neighbor) an email from the engineering firm PCR has subsequently hired, asking for contact information for residents and interested parties. I replied directly to Maria Cruz of Souder, Miller and Associates with my information and request to be included in all public outreach efforts. Ms. Cruz replied promptly, verifying she had received my contact info and had me on their list. I have not received any further information or meeting announcements from either Souder, Miller and Associates or PCR, even though three meetings were held at the Vista Grande Community Center. This leads me to wonder if PCR is serious in endeavoring to meet their public outreach obligations; I am a highly motivated participant in the process, making their job easier, and still they are not meeting the minimum expectation of good faith communication. In this frame of mind I attended one of PCR's information sessions, (having been notified, again, by a neighbor, NOT PCR or its agent) and while they had more slides in their PowerPoint, they were no more informative in their answers to our questions, most of which were on the same topics raised at the October 8th meeting, namely:

- 1. **Fire safety and suppression plans**: there was vague talk about an 'expert' PCR had hired but who wasn't able to attend the meeting that day; there was vague and circular talk about consulting with Sandoval County Fire personnel, but with Sandoval County personnel being the furthest possible emergency entity from the proposed site, that is not a reasonable or substantive answer.
- 2. Water usage and sourcing: again, Mr. Brandi could not assure with any credulity that water would not be pumped from the local supply for use in construction as well as Operation & Maintenance, namely washing the solar panels with what they estimate will be 25 large water trucks per year. That is not an insignificant amount of water in an area where many people have wells that have gone dry and depend on the same public source that PCR hopes to use, the Henderson well in Golden. No formal agreement between Hendersons or any other water supplier has been submitted with this application, which seems a very significant lack in necessary proof of plan for this project.
- 3. Access to the proposed site: PCR states in section 2.4 of their application (page 7, item 2) that "During construction, the Project site will be accessed from NM-14 across the Rancho de Chavez, located in Santa Fe County. This access route across private land will also be used in the event of an emergency during the operation period of the project. PCR has entered into an agreement with the landowner to facilitate use of this access route. The executed Memorandum agreement was recorded at Santa Fe County." They have NOT submitted a copy of this agreement with their application, nor have they entered it into the record in SANDOVAL COUNTY. This oversight is extremely concerning to me. If this "agreement" is at any point broken, or terms change, I and my Puertecito neighbors could be subjected to dangerous heavy construction traffic on our roadway, which is NOT

sufficient to safely support that volume, weight or type of traffic. We have been subjected to this before, when PNM used Puertecito Road to construct a power line and switching station. It incumbent upon Sandoval County not to endanger their citizens by letting this happen again. The County must diligently pursue all assurances that PCR will not endanger the residents of Puertecito Road with construction-grade traffic; requiring proof of a legal, binding, memorandum of agreement with Rancho de Chavez granting access from NM 14 to the solar site seems the bare minimum the County should require. I would also ask, if they have an agreement for *construction* traffic through Rancho de Chavez, then why not ALL traffic? PCR suggests their daily Operational and Maintenance traffic will be equal to 4 passenger vehicles per day, which on its face seems minimal. But under further examination of their application, they state 25 large water trucks per year will be an additional amount. Given their history of vague, evasive or just plain missing answers to our questions, it is very difficult to trust these estimates of traffic volume. They haven't even explored the possibility of accessing the site from I-25, which would be a much more direct route that involves NO residential impact, would be faster for Sandoval County emergency services to reach the site and would mean no heavy truck traffic on The Turquoise Trail Scenic Byway, NM highway 14. It is absurd that a route directly from Interstate 25 hasn't been their prime objective, as their proposed route utilizing the Turquoise Trail degrades and endangers life in East Mountain communities stretching from Tijeras all the way to Madrid.

I believe it is the Planning and Zoning and County Commission's duty to require a much more thorough, transparent and inclusive proposal from PCR; to grant this zoning change at this stage would be premature and would undermine the necessary due diligence and oversight that is the County's mandated responsibility to us, the residents and citizens of Sandoval County, as well the East Mountain communities also impacted by this proposed project.

I'm writing to ask that you please deny the PCR Energy request for a zoning change. The request to convert agricultural/ranchland into an industrial park is not in character with the surrounding properties along the Turquoise Trail National Scenic Byway.

Location and topography matter. This is not a flat area. This 1800 acre (2.8 square mile!) solar farm and battery storage facility will be at a lower elevation than many of our Sandia National Forest recreational areas and local communities. It will be THE THING one will see from the Sandia Ski Area, many of the trails in the Sandia National forest, and yes, from many homes north and east of the Sandias.
