- 2. Lodgers' Tax Financial Report Dora Dominguez, Sandoval County Tourism Director
  - a. FY24 Budget prior year carryover \$20,921.92. FY25 Lodgers Budget prior year carryover \$33,421.92. Year-to-date (July 1, 2024 through January 6, 2025) the total amount of Lodgers Tax received is \$3,602.93.

FY25 Lodgers' Tax Revenue Budget - \$13,000.00

The use of lodgers' tax remitted by short-term rentals adheres to state statute and county ordinance as no less than 50% to be used for tourism marketing. Per state and county ordinances up to 50% can be used to support administrative costs related to staffing assistance at the El Zocalo venue and visitor center. **Note**: The sole source of lodgers' tax revenue for Sandoval County (unincorporated areas of the County) is from short-term rentals. The county's Tourism Department staff continues to strive to simplify the STR lodgers' tax remittance process for the County. STR owners now can remit lodgers' taxes online with a credit card or bank draft.
