This is to formally notify you that your appeal will be heard Tuesday, February 18th, 2025 at 11:00 AM. As the hearing will be a quasi-judicial proceeding and in order to provide a fair hearing for both the appellants and the applicant, the following procedures will be followed:

- Both the appellants and applicant will each have a <u>total of 25 minutes</u> to present their case. (<u>Note: Appellants will be expected to coordinate their presentation so that they do not exceed the allotted total of 25 minutes for their presentation.)</u>
- No public comment will be heard; only the parties to the appeal will be allowed to speak.
- Appellants will open the presentations with a 20 minute presentation. They will have an additional rebuttal period of 5 minutes following the applicant's presentation.
- The applicant will have 25 minutes to present. No rebuttal period will be provided.
- Each party will have 5 minutes to make a closing argument.
- Evidence will be limited to the record of the initial Planning and Zoning Commission hearing.
- Following the presentations of both the appellants and the applicant, members of the Board of County Commissioners (BCC) may ask questions of the parties and/or staff.
- The BCC may vote to enter executive session to deliberate or continue in the public session.
- Any decisions by the board will be the result of a public vote in open session.
