L CALL TO ORDER

Chair Heil called meeting to order at 5:00p.m. Present were Chair Meek, Vice Chair Juarez, Commissioner Bruch, Commissioner Herr, and Commissioner Jones via telecommunications.

2. STATUS OF THE TREASUERER'S OFFICE

Treasurer Taylor wanted to start off by welcoming the newly elected commissioners, Vice Chair Juarez and commissioner Herr. Treasurer Taylor discussed the Treasurer's Staffing and the recent retiree of almost 40 years of service with Sandoval County in the Treasurer's Office. Annette Chavez was the Treasurer and Collection Supervisor and had a huge amount of institutional knowledge. Therefore, they needed to ensure that whoever would replace her not only had the supervisory background but also some knowledge on property taxes, refunds, payroll and tax roll collections.

Treasurer Taylor presented the 2024 First Half Collections. Treasurer Taylor discussed House Bill 47, the increase in exemption from \$4,000.00, this bill will change the exemption. Treasurer Taylor updated the Commission on the letter of credit and bank balances.
